Greg Lindvig Variance Request	N9482 McIntosh Road - Tax Parcel 5-459-2 This land parcel is 8.1 acres and currently does not have any other sheds built upon it. Per La Crosse County this size of parcel would allow for a 3,200 square foot shed that is 21' high. Mr. Lindvig is requesting to build a pole shed that is 45'x81' (3,645 sq ft) and approximately 22'6". That is approximately 450 sq ft larger and 1.5' higher than county restrictions. The reason noted for needing this height variance was to accommodate a taller camper. The excess square footage is needed to allow for storage of multiple other items including a tractor, snowmobile, ATV, UTV, trailer, and boat among other items. Based on previous discussions regarding his potential plans, Greg did not foresee any objections from neighbors. Mr. Lindvig presented an aerial photo of his property to show his planned placement for the shed and explained that that the shed would not be easily seen from the road or by neighbors. Mmsp: (Paul / Joan): Motion to approve variance of height up to 23 feet and square footage of 3,645. Action: Greg will need to have the request be placed onto the May Town Board Meeting agenda. He will also need to work with La Crosse County for final approval.
