Call to Order	The meeting was called to order by Dan Heidel at 7:30pm
Meeting Minute Review	Mmsp: Lash / Raabe: Motion to approve the August 21, 2018 minutes with a small correction to the current zoning of the 3 acre parcel within Iverson request.
Bug Tussel Chris Henshue	Bug Tussel Representative, Chris Henshue, was in attendance to request approval for conditional use permits to be applied to three different building sites in which the company plans to construct high speed internet towers.
	Mr. Henshue explained that the company's mission was to bring high speed internet to rural Wisconsin and is planning the construction of 20 towers within La Crosse County.
	Each of the tentative towers in the Town of Farmington will be 300' high and will project high speed internet signals. Each will likely be equipped with FirstNet a cellular signal service, as well, that will ensure dedicated signal for First Responders and Fire Departments. These towers could potentially offer commercial AT&T cellular signal also. Setback requirements set forth by La Crosse County will be followed and a bond clause has been added into the county's agreement already that will ensure that monies will be available to remove and restore the land in the event towers are no longer in service. The Service provider noted that the company never oversells so internet speed will not be an issue for consumers and was confident that weather does not interfere with signal.

Further tower sites would require additional approvals.

Nick Sinotte Request to lift deed restrictions	County Road D and Hall Road (Parcel: 5-1556-0) Via telephone, Mr. Sinotte, explained his plans to construct a house onto a 17.2 parcel of land that is currently owned by his Mother In-Law. He noted that this parcel along with six other parcels is part of a larger Base Farm Tract that is deed restricted to not allow the construction of any other residential buildings.
	It is the committee's understanding that these restrictions were put into place based on a 2012 statewide BFT farmland conservation statute. That said, the committee does not believe that the Township has the authority to lift such restrictions but would like to confirm this understanding with the county before making the final recommendation.
