## **CALL TO ORDER:**

Dan Heidel called the regular Plan Commission Meeting to order at 7:30pm.

## **TRI-COUNTY TRAIL BLAZER ATV CLUB**

Ray Green, on behalf of Tri-County Trailblazer ATV Club, was in attendance to request the revision of the current ATV Ordinance 2-2019 and allow the opening of all town roads within the Town of Farmington to All-Terrain-Vehicles.

With this request, he also asked that the Town of Farmington Plan Commission positively recommend the opening of all county roads within the township, as well as, State Road 108 from Davis Creek Road to County Highway C.

Currently the majority of town roads are already open to ATV usage. Outside of concerns raised by Heidel related to existing routes, the commission did not note any further concerns or reasons not to recommend approval of all three requests.

**Mmsp: LASH / FENSKE:** Motion to recommend approval of all three requests as presented. This motion includes the recommendation to revise Ordinance 2-2019 and allow all-terrain-vehicle usage on all town roads. Through this motion, as well, the PC recommends opening all county roads within the township and a portion of State Highway 108 from Davis Creek Road to County Highway C to all-terrain-usage. **PASSED 4/0/0** (Michael White was not in attendance until after motion was passed)
