CALL TO ORDER:

Chairman, Mike Hesse, called the regular Town Board Meeting to order at 6:00pm.

Farmington Sanitary District – Main Lift Station Replacement Project

Carson Hacket, representative of Davy Engineering, was present to share bid summaries collected for the Farmington Sanitary District Main Lift Station Replacement Project. The bids were opened earlier in the day following the noticed 2:00pm deadline.

Mr. Hackett presented the summaries, sharing that three bids were received, and the prices were competitive. The Base Bid for the Main Lift Station was Flygt, which totaled to \$410,000.00 in Winona Mechanical's bid. They also listed an alternate to the Base Bid for a Gorman Rupp station, providing a deduct from the base bid of \$52,700.00. Their recommendation includes accepting Winona Mechanical's alternate bid for Gorman Rupp and accepting the deduction. The bid also includes an engine generator manufactured by Generac, the Base Bid. Winona Mechanical has experience doing this type of work and has completed numerous lift station replacement projects in recent years.

Total cost of the project according to the recommended alternate bid submitted by Winona Mechanical totaled to \$608,000. After deducting the anticipated \$350,000 of federal monies awarded to the town through works of Senator Baldwin, the town is expecting to finance the remaining \$273,887 using a 20-year clean water fund loan that offers a 2.145% interest rate.

This loan amount will be split amongst all Farmington Sanitary District households.

Public Works Lawn Mower

The board reviewed and discussed two quotes collected by Mitch Fenske for the possible purchase of a new riding lawn mower to be used by the public works crew for maintenance of the public property including parks and cemeteries. Recommendations by Fenske were shared. The board made no decision and requested that Fenske collect an additional quote.
