LaCrosse County	<p>ATV Ordinance Review</p> <p>The TB previously agreed to the ATV ordinance as it was proposed to them by LaCrosse County. The board did, however, accompany their approval with the recommendation that they add to the document a clause that limits the hours of operation as well as a clause that makes liability insurance mandatory.</p> <p>Despite these changes already being communicated to the county, Dan Heidel wished the recommendations recorded within the PC minutes as well.</p> <p>Mmsp: Heidel / Raabe: Motion to recommend the ATV ordinance as drafted and received from the county on June 17, 2020 with the addition of adding hours of operation and a clause making liability insurance mandatory for all operators.
